# PARADE RULES AND INFORMATION

The following rules and information apply to all participants in the Simi Valley Days Parade.

1. No person is permitted to participate in the Simi Valley Days Parade unless they are willing to follow and be bound by these rules and accompanying information.
2. Simi Valley Days Foundation, Inc. ("Simi Valley Days") requires all participants in Simi Valley Days activities to sign a general release waiving liability against Simi Valley Days Foundation, Inc. and its officers. No person may participate in the parade unless:
  - a. They have signed the release;
  - b. A parent or legal guardian has signed the release on their behalf; or
  - c. They are participating as part of a group (e.g. a school band, social organization, church or business) and such group has authorized an individual to sign a release on the behalf of the entire group. In such cases, the authorizing individual must attach a list of names of participants to the back of the general release.
3. **Insurance.** All participants must be covered by a liability policy in the amount of \$1,000,000. This may be in the form of a rider on another policy such as home or auto, or groups may purchase insurance directly from the Simi Valley Days Foundation, Inc. Insurance carrier. [Insurance application form](#). Insurance provider must supply Simi Valley Days Foundation, Inc. with paperwork naming Simi Valley Days Foundation, Inc. as additionally insured.
4. **Registration.** All units must be registered with the Simi Valley Days Parade Committee in order to participate in the parade. All registrations must be received prior to 12:30 P.M. (accompanied by a signed release) August 31st, 2009. There will be no exceptions. Individuals, units, and groups desirous of participation may register by one of the following methods:
  - a. *Mail.* The Parade Committee welcomes applications sent in by mail. To obtain an application, please click [here](#). Please mail the application to Simi Valley Days Parade PO Box 1328 Simi Valley, CA 93062 all eMailed applications must be followed by hardcopy delivery by mail and include all support documentation and fees.
  - b. *Online.* You can obtain an application online. Applications must be complete and include a phone number and name for the contact person. All support documentation and fees must be delivered to Parade committee no later than the final deadline.

No application will be accepted that is not properly and accurately completed. All required information must be given.

5. **Check-in.** All units must check-in at parade headquarters by their assigned check-in time on the day of the parade. Check-in is required so that the parade committee may verify that all required information has been submitted and/or collected, provide you with any necessary last minute instructions or changes, provide you with line-up instructions, and give you your march order assignment.
6. All floats for judging must be checked-in and in the staging area by 7:30 A.M. Judging will be between 7:30 A.M. and 8:30 A.M.
7. Nothing is to be thrown from parade units, including candy. Violations of this rule may result in the immediate withdrawal of a unit from the parade and a one year suspension from parade. This rule is a safety rule.
8. Following safe procedures, please secure all persons on floats: children are to be accompanied by adults and do not pick up riders while enroute.
9. Walking units, autos, tractors, etc. must be in the staging area at their assigned location no later than 8:00 A.M.
10. **ALL DRIVERS MUST BE 16 YEARS OF AGE AND POSSES A VALID DRIVER'S LICENSE. NO EXCEPTIONS!**
11. One seat/one person rule will hold true.
12. All automobiles must be able to provide proof of insurance.

13. Identity of participants must be recognizable. Hoods and masks are prohibited unless a special exemption is given by the parade chairman.
14. Any questions or judgments should be directed to the parade chairman and the chairman's ruling shall be final. The chairman shall have the authority to make any changes or exceptions to these rules at any time he believes such changes or exceptions will promote safety or better facilitate the conduct of a successful parade.

**FAILURE TO FOLLOW THE PARADE RULES CAN RESULT IN IMMEDIATE EXPULSION FROM THE PARADE.**

# Parade Facts & Information

Complete and sign both sides of the parade application. Entries must be received by August 31, 2009. Entries will be limited to a total of 125. Application does not guarantee entry. The Parade Committee will approve entries based on use of theme and entertainment value as determined by parade committee. Line-up position is based upon type of entry. Early submission of completed application, insurance certificate, hold harmless agreement and entry fee will be given consideration.

**Only fully completed applications (both sides) received with insurance declarations and entry fees will be considered. All participants must provide 1) proof of liability insurance indicating a minimum of \$1,000,000 liability coverage and naming the Simi Valley Days Foundation, Inc. and Simi Valley Days Committee as additional insured and 2) signed hold harmless agreements on the back of application. Insurance may be purchased through the Simi Valley Days Foundation, Inc.; Please see, "2009 Parade Participant's Application for Additional Insurance Endorsement" inside this application.**

All entries will be prejudged. The fire department requires all floats to avoid the use of highly flammable materials and to carry a 2A 10BC rating household fire extinguisher. Floats may carry only the name of the sponsoring firm or organization (no phone numbers or addresses). Judging will be based on execution of theme and originality of design. Floats may be self-propelled or towed by a decorated vehicle. **If a truck, cab of vehicle must be decorated. It is desirable for the float theme to be carried out so that it may be seen as it approaches the spectators. We encourage sound and motion in float design.**

There will be awards for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places in each class with sufficient entries.

Equestrian Judging will be by Rex Machlan, Licensed Judge for the California State Horseman's Association. Equestrians will be pre-judged. **All horses must have intra-oral bits.**

Some Awards will be given when the entry arrives at the step-off line. Judging results sheets will be posted at the SVD Committee booth at the carnival grounds at 4 00 P.M. the day of the parade.

Automobile Liability written through an insurer rated A+ {or better} by Best's Rating Guide or a California admitted Insurer with limits of liability not less than \$1,000,000 per person / \$1,000,000 per occurrence for Bodily Injury and \$1,000,000 Property Damage limit or \$1,000,000 Combined Single Limit of Bodily Injury and Property Damage liability.
